Set-up begins at 10:00am. Booths are to be ready no later than 11:00am. One booth/vendor per paid location. Booths must stay open until at least 3:00pm.

Vendor must provide at least one equipment knowledgeable adult to man the booth and be able to act in the case of equipment malfunctions.

Vendors must provide their own signage.

Sales tax collection and reporting must be handled by each vendor and all appropriate information is reported to the Nevada Department of Taxation by each vendor.

Applications are not considered accepted or complete until all required documents have been turned in.

Fee is due with the application and will be refunded if not approved. Your \$50 fee is reimbursable the day of the event when you bring an item or service valued at \$50 or more for
